# **Deal Intelligence Dashboard – Terms of Use**

Last Updated: August 4, 2025.

Please read these terms carefully before accessing and/or using the Deal Intelligence Dashboard Service (defined below). By clicking "I agree", "Accept", "Send", or any other similar button, or by registering for, accessing or using the Deal Intelligence Dashboard (defined below), you expressly acknowledge and agree that you, on behalf of yourself and your organization ("you" or "Customer"), are entering into an agreement with Start-Up Nation Central Ltd. (CC) ("SNC"), and understand and agree to comply with, and be bound by these Deal Intelligence Dashboard Terms of Use ("Deal Intelligence Dashboard Terms") and SNC's general website terms under the following link: <a href="https://startupnationcentral.org/terms/">https://startupnationcentral.org/terms/</a> ("SNC General Terms"), which are incorporated herein by reference and which shall also govern the use of the Deal Intelligence Dashboard Services (defined below), and the date of such occurrence, being the "Effective Date". Any capitalized terms not defined herein shall be defined under SNC General Terms.

If you are accessing or using the Deal Intelligence Dashboard Services (defined below) on behalf of an organization (or other legal entity), you hereby represent and confirm that you have authority to bind the organization to and accept these Deal Intelligence Dashboard Terms. If you do not have such authority, or if you do not agree to these Deal Intelligence Dashboard Terms and/or SNC General Terms, you must not access or use the Deal Intelligence Dashboard Services (defined below).

# 1. Pre-Approval for the Deal Intelligence Dashboard Services

Access to the Deal Intelligence Dashboard is free of charge and provided only to users pre-approved by SNC at its sole discretion. Failure to obtain pre-approval will result in the denial of access to the Deal Intelligence Dashboard Services.

SNC agrees to provide to Customer the services provided under the deal intelligence dashboard under the link provided by SNC ("**Deal Intelligence Dashboard**"), as may be amended by SNC from time to time, and any other services provided by SNC under the Deal Intelligence Dashboard (collectively, the "**Deal Intelligence Dashboard Services**").

### 2. Quarterly Data Updates

To maintain access to the Deal Intelligence Dashboard Services, you must email SNC at <a href="mailto:finder@sncentral.org">finder@sncentral.org</a> a completed Excel file by the end of each calendar quarter. This file must include the following up-to-date and accurate information ("**Updates**"):

- Information related to the investment activity of the Customer (total funding rounds, amounts invested);
- Customer's updated Finder investor profile data (stages, sectors, team, etc.); and
- Any information requested by SNC related to Customer's Finder profile.

Failure to send the Updates, as may be updated from time to time by SNC, may lead to reminders and eventual suspension and/or denial of access to the Deal Intelligence Dashboard Service.

#### 3. Modifications

SNC reserves the right to modify these Deal Intelligence Dashboard Terms at any time and in its sole discretion. Such modification will be effective four (4) days after being posted in the following link: <a href="https://lp.startupnationcentral.org/media/Deal-Intelligence-Terms-of-Use-10.6.25-clean.pdf">https://lp.startupnationcentral.org/media/Deal-Intelligence-Terms-of-Use-10.6.25-clean.pdf</a>.

Your continued use of the Deal Intelligence Dashboard Service shall be considered as acceptance to the then most updated Deal Intelligence Dashboard Terms. Notwithstanding the foregoing, SNC may change the Deal Intelligence Dashboard Services, effective immediately at its sole discretion.

# 4. Suspension and Termination

Term. The Deal Intelligence Dashboard Terms shall be in effect on the Effective Date and shall continue until the end of the then current calendar quarter ("**Trial Period**"), unless earlier terminated in accordance with the terms specified herein. Notwithstanding the foregoing, in no event shall the Trial Period be shorter than seven (7) days; therefore, if on the Effective Date, fewer than seven (7) days remain until the end of the thencurrent calendar quarter, the Trial Period shall be automatically extended until the end of the following calendar quarter. Following the Trial Period, these Deal Intelligence Dashboard Terms shall be automatically renewed for successive quarterly periods if the Customer has duly performed all the Updates prior thereto and if such Updates are approved by SNC, unless terminated earlier as set forth herein.

<u>Termination by SNC</u>. SNC may temporarily suspend or permanently terminate your access to the Deal Intelligence Dashboard Services at any time:

- With or without cause, upon three (3) days' prior notice;
- Immediately, if you fail to comply with these Deal Intelligence Dashboard Terms and the Updates obligations hereunder; and/or
- As required by law or at the request of governmental entities.

<u>Consequences</u>. You will not be entitled to any compensation upon suspension or termination of the Deal Intelligence Dashboard Services and/or the Deal Intelligence Dashboard Terms. In addition, and at any time upon SNC's request, you shall promptly return or destroy, as directed by SNC, all copies of the information or materials provided by SNC as part of the Intelligence Dashboard Services.

## 5. Additional Terms

<u>Conflict of Terms</u>. These Deal Intelligence Dashboard Terms shall not derogate from any of SNC's rights specified under SNC General Terms. In the event of any conflict between any terms of the Deal Intelligence Dashboard Terms and the terms of SNC General Terms, the terms of the Deal Intelligence Dashboard Terms shall govern and control with regards to the Deal Intelligence Dashboard Services, unless specifically specified otherwise.

<u>Survival</u>. The provisions of the preamble, Section 4, this Section 5, and any other provision of these Deal Intelligence Dashboard Terms which, by their nature or express terms, are intended to apply or remain in effect after the termination or expiration of these Deal Intelligence Dashboard Terms, shall survive such termination or expiration and shall remain in full force and effect for the period specified therein, or, if no such period is specified, indefinitely.
